

## History Lesson

On January 5, 2021, Modesto Restaurateur, Stan Galas passed away. Stan Galas (1934-2021) and his brother Norman (1931-2008) were the owners of Modesto's Sundial Lodge. The Sundial is synonymous with Modesto history. When prompted by long-time Modesto residents which business they miss most, the usual answer is the Sundial. Mr. Galas' death seem to be the end of a very important chapter in Modesto, so it feels fitting to give a history of an establishment which operated for 42 years (1956-1998).

The story of the Sundial dates back to Hotel Covell. In 1924, George (1865-1948) and Grace (1884-1973) Covell opened their Hotel in Downtown Modesto on J Street. Gus Galas (1901-1990) and his brother, Emmanuel (1894-1985) immigrated to California from Greece and opened the Oakdale Café in 1945. The following year, Geroge Covell offered the brothers a position running the restaurant in the Covell. Following her husband's death, Grace Covell moved into a large home on McHenry Ave, and decided to open a lodge nearby. In 1956, she opened the Sundial Lounge at 808 McHenry Ave and Gus Galas and his wife, Nora (1907-1993) ran the restaurant along with their sons Norman and Stan.

The Sundial became the number one eatery in the city. Their menu was simple, Prime Rib, Pot Roast, Roast Turkey, but it was a hit with the local crowd. Their breakfasts were a favorite morning ritual for many. The Sundial was the place to stop when visiting Modesto, and played host to many notable figures passing through the city. Actors like Jim Backus, Agnes Moorehead, George Gobel, and another famous Modesto business, the Johnny Weissmuller and athletes like Willie Mays, always ate at the Sundial while visiting Modesto.

In 1972, the Galas Family purchased the building from Grace Covell. Following their parent's retirement in the 1980s, Norman and Stan Galas decied to close the Sundial on July 31, 1998. The Modesto Bee reported "Summer 1998 the nation loes Buffalo Bob, Roy Rogers, Frank Sinatra. Modesto Loses the Sundial." Many of the furnishings of the Sundial were purchased by Carmen Sabitino for his Restaurant "Sabatinos," also on McHenry, and remained there until its closing in 2019. The Sundial Lodge structure was converted into an assisted-living/nursing facility and remains under the name Stacie's Chalet.

## **Updates**

A reading of a Memorandum of Understanding (MOU) occurred between the City of Modesto and the MMH&S and has been sent to the city attorney's and is expected to be approved by April 2021. A memorandum of understanding is an agreement between two entities. The City owns the building and the majority of the contents, and the MMH&S serves as a support system for the building and helps alleviates certain burdens from the city in maintaining the building.
